#### Immiticide 45-66 lbs.

Heartworm disease is very serious and complications may arise during and after treatment. Please follow these instructions carefully to lessen the chances of problems developing.

- 1) Exercise: Baloo's activity must be severely restricted for the next 5 weeks. Short, on-leash walks are the only exercise allowed until both phases of the treatment have been completed. Also, prevent Baloo from engaging in vigorous or extended barking, rough play or other excitement.
- 2) Please notify the hospital if any of the following occur: Baloo refuses to eat normally. Baloo has diarrhea, vomiting or blood in the urine.

Baloo coughs frequently or has trouble breathing.
