This contract is made and entered into on 3-18-09 between the Central Brevard Humane Society (hereinafter "CBHS") and Florida Sharpie Rescue (hereinafter the "Rescuer"). By signing below the Rescuer represents and agrees to the following:

1. Rescuer represents that he/she is 18 years or older.
2. Rescuer represents that he/she has never been convicted of cruelty to animals under any federal, state, or local law.
3. Rescuer acknowledges the receipt from CBHS of ID# A06301501, a Sharpie described as a chocolate in color, for disposition in accordance with their policies and procedures.
4. Rescuer acknowledges that the information provided to the Rescuer about the animal being rescued may have been received by the CBHS from third parties and that CBHS does not warrant the accuracy or correctness of such information.
5. Rescuer agrees to be bound by and to comply with the following terms and conditions (please initial beside each requirement)

SC Humane care for this animal while in the care of rescuer and/or the rescuer's agents, foster parents, and volunteers.

SC Provide proper nutrition, secure shelter, adequate food and water.

SC Have the animal checked by a veterinarian regularly while in the care of the rescuer and kept current on all necessary vaccinations.

SC Allow the animal to be adopted only as a pet and companion; not for purposes of resale or for purposes of protection, hunting, mousing, fighting or experimentation.

SC Provide safe and humane transportation for the animal.

SC Comply with all applicable local, state, and federal laws regarding animals, including licensing.

6. Rescuer agrees to take said animal to a licensed veterinarian for a health examination and any necessary medical treatments within 72 hours after the animal's release to rescue.

7. Rescuer agrees that CBHS has no liability for the health conditions of the animal.

8. Rescuer assumes all risk and responsibility of ownership for the animal once it is in the Rescuer's possession (Rescuer's acceptance of said animal). CBHS makes no expressed or implied warranties with regard to this animal, its health, temperament, or otherwise. The animal is released to rescue "as is."


9. Rescuer must agree to spay or neuter the animal as soon as medically possible.

10. Rescuer understands that CBHS may also, at their sole discretion, make inquiry of the organization's representatives or records at any time. CBHS may also, at their sole discretion, make a site visit to the Rescuer's main facility, foster homes, kennels or any other locations where animals rescued from CBHS are housed.

11. Rescuer understands that failure to comply with all terms set forth in this contract shall constitute a breach of contract and that should such breach occur, Rescuer will be required to return the above described animal to CBHS.
