Instructions for Persy

Thank you for bringing ~~Persy~~ ^{CODGER} in for an exam today! He does have severe entropion (rolling inward of the eyelids) on both eyes, but fortunately does not have any corneal ulcerations at this time. He will definitely need surgery to correct this abnormality in the near future. For now, we are starting him on a medicated eye ointment to help keep the eyes lubricated and to help clear the superficial infection present. He also has severe ear infections and skin infections. We are starting ~~Persy~~ ^{CODGER} on several medications to try and clear these infections. The cause of the collapse episode is unknown at this time, but we will check the bloodwork to make sure that no metabolic diseases are present which might precipitate a collapse. His heart sounds normal on exam today, but there is also a chance that he could have an intermittent arrhythmia (irregular heartbeat) as well that might have led to a temporary collapse or fainting spell. Please continue to monitor him closely and let us know right away if this happens again. Please also let us know if you are having any difficulty with the medications. I would like to see Percy back in 2 weeks for a recheck. Thank you!
